
TRAVERTINE HEXAGONAL COLUMN TABLE LAMP

This fixture has been rated for up to one (1) 100-watt maximum Type A standard candelabra lightbulbs, one (1) 23-watt compact fluorescent lightbulb, one (1) 12-watt LED lightbulbs or one (1) 8.8-watt LED lightbulbs. To avoid the risk of fire, do not exceed the recommended wattage.

All wires are connected. When unpacking, be careful not to pull wires, as a bad connection may result. Do not connect electricity until your fixture is fully assembled. ASSEMBLY & INSTALLATION

- Carefully remove all parts from the box and remove all plastic coverings.
- 2. Place Lamp Body (F) on a flat surface.
- 3. Insert Harp (B) onto Saddle (E).
- 4. Insert Bulb (D) into the socket.
- 5. Place Shade (C) over Harp (B) and onto Saddle (E).
- 6. Attach Finial (A) to Harp (B) and turn in clockwise direction to secure.
- 7. Remove the red protective plug cover from the cord with plug.
- 8. Plug into proper electrical outlet and test fixture.
- 9. Assembly is complete.

CARE INSTRUCTIONS

Do not use polishes or cleaners on the fixture. Wipe clean with a soft, dry cloth.
